Lapworth & West Kenilworth News September 2019 – Councillor J Cooke

Warwick Road Lapworth Speeding Near Boot Public House

Following my meeting with the Highways engineer I have agreed to fund the scheme costing £10,000 which I sent to Lapworth Parish council which includes a gate with signage plus advance road markings. On top of this the gentlemen who made the original complaint would still like to have a large flashing sign to which he offered to make a contribution, but highways again will not approve this in that location.

School Lay-by Station Lane Lapworth

I have agreed to a request to fund a sign in the lay-by the School to prevent people parking. The Senior Officer responsible for safer routes to school will not agree to double yellow lines near the school. I have sent her reasoning to Lapworth Parish Council.

Learnington Trader Sold Counterfeit and Electrically Unsafe Products Online

A Learnington Spa trader who sold fake and electrically unsafe products online has been sentenced to 12 months in prison suspended for two years, ordered to do 280 hours of unpaid work, and has been disqualified from acting as a company director or otherwise in the management of a company for five years.

Sentencing took place at Warwick Crown Court last month. Mr Bhupinder Sandhu (aged 34 of Moorhill Road, Whitnash), sole Director of Partek Trade Ltd had previously pleaded guilty to five charges under the Trademarks Act 1994. He also admitted two offences of having in his possession for supply equipment which breached electrical safety regulations.

Sweep for Chimney Fire Safety Week

With autumn on the way, Warwickshire Fire and Rescue Service (WFRS) are reminding residents to have their chimney swept by a registered chimney sweep this Chimney Fire Safety Week (2 – 8 September). There are a number of steps homeowners can take to prevent and protect their property from fire, and getting your chimney swept is just as important as checking your smoke alarm. Last year, WFRS attended 50 chimney fires across the county and they've already attended 26 so far this year, so it is important not to become a statistic by taking the necessary steps to prevent and protect your property.

Some of the most common causes of chimney fires are infrequent sweeping and cleaning, burning unseasoned wet wood and overnight burning. To keep your wood burning stove safe and to make the most of it, ensure you are using quality woodfuel, maintain your appliance and chimney regularly and check you are using your appliance in accordance with the manufacturers' instructions.
