### 123. CIL Funding

a) Proposed improvements to the Playing Field, Play area improvements, outdoor adult gym equipment, community orchard space and wildflower planting for biodiversity and consideration of a footpath around the boundary of the play area.

The Clerk reminded members that the proposed works at the Playing Field had been on hold for some time, due to apparent covenants on the land. However, it was now confirmed that the area where there are covenants, is the area between the two goal posts. The play area does not hold any covenants and has no other covenant other than it must be used for recreation for the parish.

The Clerk had also received a suggestion from members of the public, for the PC to make consideration for a path to be laid around the boundary of the play area, using materials such as concrete, or compacted sand/gravel (preferred) or tarmac. This could be used for childrens' bicycles, scooters, wheelchairs etc all year round. The Clerk suggested that the PC should consider holding a Public Consultation at Rowington Village Hall on Thursday 24 March 2022 between 7pm and 9pm.

All parishioners would be invited via the Ferncumbe News, Next-Door Rowington and personal emails.

Councillor B Sandford offered to print and display the proposed plans at the hall.

This would an open and informal meeting, where people can come along at any time between 7pm and 9pm, or via email if they cannot make the meeting.

A ballot box would be available, along with a short questionnaire so that parishioners may submit their views either openly or anonymously, or via email if they were unable to attend the meeting.

The proposal was agreed unanimously and the Public Consultation would be arranged for 24 March 2022.

# b) Gateway Signage

Councillor D Weir agreed to defer this item and bring it to the attention of members of the public at the Public Consultation to be held on 24 March 2022.

# c) Benches – Queen's Platinum Jubilee

The Chairman had circulated costs and examples of wooden benches supplied by a local person, and it was agreed that the Parish Council set aside a budget of £3,000 to purchase three benches to mark the Queen's Platinum Jubilee. Those benches would be installed on Rowington Cricket Pitch, Pinley Green and a site near to Lowsonford Village Hall. Councillor Coles agreed to liaise with Lowsonford Village Hall Trustees to source a suitable location.

# 124. Queen's Platinum Jubilee – 2 to 5 June 2022

Following deliberations, Members agreed that the Parish Council should mark this event and given the short time frame, it was resolved unanimously to approve a Queen's Platinum Jubilee Committee to allow that Committee to make decisions independently.

The Clerk, and Councillors I Henderson, D Weir, A Marsden and B Sandford agreed to meet and engage with representatives of other organisations in the hope that the Parish Council could plan an event to mark this occasion, along with co-opted members from local organisations.

It was also agreed unanimously to set a budget, in principle of £2,500 and the Clerk would pursue other avenues for funding opportunities.

### 125. Defibrillators

The Clerk reported that the person who currently checks the AED at Lowsonford Village Hall, was looking to step down after many years.

Karen & Mike Lowe offered to assist and the Clerk agreed to liaise with them to arrange a takeover date and ensure that adequate information was supplied.

Warwickshire residents are warned to check their chimneys as Warwickshire Fire and Rescue has attended a series of chimney fires across the county recently.

The Fire and Rescue Service has been called out to chimney fire incidents in Learnington Spa, Rugby and Northend just in the last seven days.

Chimneys require sweeping at different intervals depending on the fuel used.

Chimneys which use smokeless fuel or bituminous coal - at least once a year Chimneys which use oil - once a year Chimneys which use wood - quarterly when in use

# **Report from District Councillor R Hales**

We are still progressing our merger with Stratford District Council and have started work on working on our IT & digital strategy and delivery.

We have also been working on our budget for 2022-23. As you maybe aware we have only received a one year settlement from central government, so that does make forecasting & budgeting trickier, especially with energy prices & inflation concerns. However, the headlines of what is being proposed is a freezing of council tax, putting an additional £500,000 into the climate emergency fund and the creation of a £200,000 hardship fund for residents. We are also proposing a green bin charge to be rolled out later in the year. As a council we are committed to not cutting the level of services that residents receive, even with our budgetary issues.
